4. Complete my training/studies, return to Bhutan and continue with the service of the Bhutan Electricity Authority for minimum period of two times the duration of the course subject to minimum of one year, unless the Authority transfers my services in the interest of the Bhutan Electricity Authority.
5. Pay to the Bhutan Electricity Authority an amount equal to two times the expenditure incurred by the Bhutan Electricity Authority or external funding agencies on my training if:
  - a) I discontinue the training for a reason other than ill health;
  - b) I failed in the course; or
  - c) I return to Bhutan/Bhutan Electricity Authority without completing training;  
or
  - d) I do not return to Bhutan upon completion of my training; or
  - e) I return to Bhutan but voluntarily resign from the Bhutan Electricity Authority without rendering specified duration of service.

I, hereby, do confirm that I have been briefed on all rules governing my training and I have understood them, including the implications and consequences of deviating from them.

In particular, I understand that in the event that I do not adhere to any one of the above stated conditions, the guarantor and/or I shall be liable for legal action by the Bhutan Electricity Authority.
